I have approved. As I understand it, the deputation is based on the same language that has been used in other national security special events, such as the Inauguration. The deputation is for 30 days and includes authority for all Title 18 offenses as well as to protect and defend federal buildings and personnel. It does not convey authority to participate in federal drug investigations unless deputized by the DEA or FBI, nor authority while off-duty. I understand the USMS Office of General Counsel has reviewed the scope of mission and has concluded that it contains the necessary authorities. The authority of Special Deputy US Marshal provided by the deputation includes the authorities under the DC Code.

Agents who are deputized will complete a short form, be administered an oath, and the USMS will keep the forms as the record of the specific agents who have been deputized.

I know there was discussion of BOP deputations as well, is that coming, or has that been handled otherwise?

Their limitations would be:

- Not authorized to participate in federal drug investigations unless deputized by DEA or FBI
- Not valid off duty

Due to the large size of this Special Deputation cohort, no additional documentation is included with this request as per usual procedure. However, all personnel have qualified with their primary issued firearm and none are under internal investigation. All have the training and experience the US Marshals Service deems necessary for carrying out the law enforcement duties that would be granted through Special Deputation.

Pursuant to the Deputy Attorney General's memorandum dated December 9, 1999, the Deputy Attorney General retains authority in seven categories of Special Deputations. This request falls within Category 5, where the deputation is for the purpose of granting federal law enforcement authority to a federal employee.

**RECOMMENDATION:** 

The U.S. Marshals Service recommends that the Deputy Attorney General approve this request for Special Deputation for a period of 30 days (June 1, 2020 through June 30, 2020). The law enforcement officers from DHS all meet the requirements for Special Deputation based on their law enforcement training and experience.
