





Dear DOJ and ED colleagues,

I'm reaching out - here in my personal capacity - simply to make sure you're aware of these developments, involving two alleged sexual assault incidents dating back months that were only recently made public. Obviously, any allegation that a school district has mishandled alleged sexual assaults is a serious Title IX issue and a serious gender justice issue. Neither particular political posturing swirling around this case nor the broader, concerning escalation of hostility toward school board members in Loudon or elsewhere, changes that.

I do want to flag that these cases have been muddied by claims, currently unsubstantiated, that one of the alleged assailants was gender-fluid, and that this has something to do with LGBTQI+ inclusive policies later adopted by Loudon County.

Further - and part of why I'm reaching out today - this matter was made a major focus of today's Senate Judiciary Committee nominations hearing.

I've copied some key coverage below. Note that some mainstream news outlets have chosen to report on the unsubstantiated claims around one incident while making clear they have not been substantiated, while others have evidently seen fit not to mention them.

Virginia Man Sentenced for Producing Images of Child Sex Abuse

WASHINGTON – A Virginia man was sentenced today in the Eastern District of Virginia to 19 years in prison for the production and distribution of child pornography.

Kevin Hewlett, 36, of Bluemont, was convicted by a federal jury on Oct. 8, 2020, of producing and distributing child pornography. According to court documents and evidence presented at trial, Hewlett was a farrier, a craftsman who trims and shoes horses' hooves. He was hired to be the farrier to a minor girl's horses. Hewlett began communicating with the minor regularly through text messages and social media applications. Then in August 2018, Hewlett recorded himself engaging in sexually explicit conduct with the minor in his bedroom. A few months later, in January 2019, Hewlett sent the minor the recording.

Acting Assistant Attorney General Nicholas L. McQuaid of the Justice Department's Criminal Division, Acting U.S. Attorney Raj Parekh of the Eastern District of Virginia and Assistant Director in Charge Steven M. D'Antuono of the FBI Washington Field Office made the announcement.

This case was investigated by the Loudoun County Sheriff's Office and the FBI's Washington Field Office's Child Exploitation and Human Trafficking Task force, which is composed of FBI agents along with local, state, and federal partners.

Trial Attorney Gwendelynn Bills of the Criminal Division's Child Exploitation and Obscenity Section and former Assistant U.S. Attorney Nathaniel Smith III of the Eastern District of Virginia prosecuted the case.

This case was brought as part of Project Safe Childhood, a nationwide initiative launched in May 2006 by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by U.S. Attorneys' Offices and the Child Exploitation and Obscenity Section, Project Safe Childhood marshals federal, state and local resources to better locate, apprehend and prosecute individuals who exploit children via the internet, as well as to identify and rescue victims.
