PROPOSED DECISION

Claimant, ANGIE ERSOLA ESCHER, who owned Accrual Certificates issued by the Consolidated Railroads of Cuba, asserts a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Railroad.

In our decision entitled the Claim of Meyer Lobsenz (Claim No. CU-1005 which we incorporate herein by reference), we held that the properties of the Railroad were nationalized or otherwise taken by the Government of Cuba on October 13, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value of such certificates as the face value thereof.

On the basis of evidence in the record in the instant case, the Commission finds that this claimant comes within the terms of the Lobsenz decision; that she was an American national at the requisite times; that she has been the owner of two Accrual Certificates in the total face amount of \$5,800.00 issued by the Consolidated Railroads of Cuba since prior to October 13, 1960; and that she suffered a loss in the amount of \$5,800.00 within the meaning of Title V of the Act. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from October 13, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See Lobsenz, supra.)

CERTIFICATION OF LOSS

The Commission certifies that ANGIE ERSOLA ESCHER suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Five Thousand Eight Hundred Dollars (\$5,800.00 ) with interest at 6% per annum from October 13, 1960 to the date of settlement.

The Commission is required to certify its findings to the Secretary of State for possible use in future negotiations with the Government of Cuba.
