PROPOSED DECISION

Claimants, ELIZABETH J. YAHN and WALTER S. YAHN, who owned a stock interest in the Cia. Azucarera Atlantica del Golfo, assert a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company.

In our decision entitled the <u>Claim of Helen M. Drye</u> (Claim No. CU-0807 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per share of \$34.056.

On the basis of evidence in the record in the instant case, the Commission finds that these claimants come within the terms of the Drye decision; that they were American nationals at the requisite times; that ELIZABETH J. YAHN has been the owner of 100 shares of stock in the Cia. Azucarera Atlantica del Golfo since prior to August 6, 1960; that ELIZABETH J. YAHN and WALTER S. YAHN have been the joint owners of 200 shares of Atlantica stock since prior to August 6, 1960; and that ELIZABETH J. YAHN suffered a loss in the amount of \$3,405.60 and ELIZABETH J. YAHN and WALTER S. YAHN jointly suffered a loss in the amount of \$6,811.20, within the meaning of Title V of the Act. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from August 6, 1960, the date of loss to the date on which provisions are made for the settlement thereof. (See Drye, supra.)

CERTIFICATION OF LOSS

The Commission certifies that ELIZABETH J. YAHN suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Three Thousand Four Hundred Five Dollars and Sixty Cents (\$3,405.60) with interest at 6% per annum from August 6, 1960 to the date of settlement, and

The Commission certifies that ELIZABETH J. YAHN and WALTER S. YAHN jointly suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Six Thousand Eight Hundred Eleven Dollars and Twenty Cents (\$6,811.20) with interest at 6% per annum from August 6, 1960 to the date of settlement.
