## A BILL

To reauthorize title I of the Sikes Act.

1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, 3 SECTION 1. SHORT TITLE. 4 This Act may be cited as the "Sikes Act Reauthorization Act of 2003". SEC. 2. REAUTHORIZATION OF TITLE I OF SIKES ACT. 7 Section 108 of the Sikes Act (16 U.S.C. 670f) is amended by striking "fiscal years 1998 through 2003" each place it appears and inserting "fiscal years 2004 through 10 2008". SEC. 3. SENSE OF CONGRESS. 12 (a) FINDINGS.—The Congress finds the following: 13 (1) The Department of Defense maintains over 14 25,000,000 acres of valuable fish and wildlife habitat 15 on approximately 400 military installations nationwide.16 17 (2) These lands contain a wealth of plant and 18 animal life, vital wetlands for migratory birds, and 19 nearly 300 federally listed threatened species and en-20 dangered species. 21 (3) Increasingly, land surrounding military 22 bases are being developed with residential and com-23 mercial infrastructure that fragments fish and wild-24 life habitat and decreases its ability to support a di-

versity of species.

- 1 (4) Comprehensive conservation plans, such as
  2 integrated natural resource management plans under
  3 the Sikes Act (16 U.S.C. 670 et seq.), can ensure that
  4 these ecosystem values can be protected and enhanced
  5 while allowing these lands to meet the needs of mili6 tary operations.
  - (5) Section 107 of the Sikes Act (16 U.S.C. 670e-2) requires sufficient numbers of professionally trained natural resources management personnel and natural resources law enforcement personnel to be available and assigned responsibility to perform tasks necessary to carry out title I of the Sikes Act, including the preparation and implementation of integrated natural resource management plans.
  - (6) Managerial and policymaking functions performed by Department of Defense on-site professionally trained natural resource management personnel on military installations are appropriate governmental functions.
  - (7) Professionally trained civilian biologists in permanent Federal Government career managerial positions are essential to oversee fish and wildlife and natural resource conservation programs are essential to the conservation of wildlife species on military land.
