SUBJECT: Law Enforcement Officer Safety Initiative

Too many dedicated law enforcement officers die senselessly each year while bravely confronting violent criminals and gangs. In recent months, we have seen a dramatic rise in the number of officers killed in the line of duty. After a two year decline in law enforcement fatalities, officer deaths in the line of duty spiked last year, making 2010 one of the deadliest years on record for law enforcement in nearly two decades. Unfortunately, this year we are on track to exceed last year's devastating numbers. Since the beginning of this year, 33 law enforcement officers have been killed by firearms or felonious assaults. This is an increase of more than 65% in fatalities compared to this same point in time in 2010, when 20 officers were killed by firearms or felonious assaults. These statistics do not reflect the number of federal, state, local and tribal law enforcement officers who have been assaulted and injured during this same time, but survived the attack.
