INDICTMENT

The Grand Jury, in and for the District of New Jersey,
sitting at Newark, charges:

COUNTS ONE THROUGH TWENTY-FOUR

1. At all times relevant to this Indictment, defendant DARLENE COVINGTON ("COVINGTON) was employed as a tax preparer at a tax preparer business, KCJ Financial Corp., a New Jersey corporation, hereinafter "KCJ," located at 1200 Clinton Avenue, Irvington, New Jersey 07011.

2. Certain financial institutions provided loans to taxpayers, known as Refund Anticipation Loans, in exchange for obtaining the rights to an income tax refund owed to the taxpayer by the Internal Revenue Service. Before extending a Refund Anticipation Loan, the institutions required a taxpayer to show that

the taxpayer had filed an income tax return with the Internal Revenue Service and that the income tax return demonstrated the taxpayer was entitled to an income tax refund from the Internal Revenue Service.

The Scheme

3. As part of the Scheme, COVINGTON obtained personal identification information, such as name and social security number (the "Personal Identification Information"), for 20 persons (the "Taxpayers").

4. COVINGTON used the Personal Identification Information, without the knowledge, consent, or permission of the Taxpayers, to prepare 24 Individual Income Tax Returns, Forms 1040A and 1040EZ, in the names of the Taxpayers for tax years 2008 and 2009 (the "Form 1040 Returns").

5. COVINGTON included materially false information on the Form 1040 Returns, which purported to show that each Taxpayer was entitled to an income tax refund from the Internal Revenue Service.

6. COVINGTON, without the knowledge, consent or permission of the Taxpayers, filed the false Form 1040 Returns with the Internal Revenue Service.

7. COVINGTON and a co-conspirator then used the filed false Form 1040 Returns to secure Refund Anticipation Loans from various banks.

8. COVINGTON received a portion of the Refund Anticipation Loan for each of the false Form 1040 Returns.

9. On or before the dates listed below, in Essex County, in the District of New Jersey and elsewhere, defendant

DARLENE COVINGTON

did knowingly and willfully aid and assist in, and procure, counsel, and advise the preparation and presentation to the Internal Revenue Service of Form 1040 Returns, for the taxpayers identified below, which were false and fraudulent as to material matters, knowing that the returns were false and fraudulent.
