OF ATTENDANCE AT SECTION 341 MEETING OF CREDITORS**

The undersigned being first duly sworn upon her/his oath, states and alleges that the answers to the following interrogatories are true and correct to the best of her/his knowledge and belief, that they are submitted as her/his sworn testimony in lieu of her/his personal appearance at the first meeting of creditors in the above captioned bankruptcy, and that he/she understands that the Trustee may have additional questions and, if so, he/she has a duty to answer them.
