## <u>ORDER</u>

On June 22, 2004, this court ordered the defendant, Jeffery Dean Hubacek, to provide the government with a complete list of persons for whom he prepared federal-income-tax returns from January 1, 2000 through present, and inform his customers of the permanent injunction imposed upon him (#32). On August 10, 2004, the government filed a motion to hold Jeffery Dean Hubacek in contempt of court for failure to comply with the June 22, 2004 order (#33). Further, on December 9, 2004, this court ordered the defendant to show cause, if any, why he should not be held in contempt of court (#34). Defendant has not filed an objection to plaintiffs' motion, nor a response showing cause.

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that defendant, Jeffery Dean Hubacek, be held in contempt of court for violation of this courts June 22, 2004 order (#32).

IT IS FURTHER ORDERED that the defendant will be fined \$2,500 per day until

he purges the contempt by: 1) complying with every requirement of the permanent injunction, 2) paying the accrued fines, and 3) certifying compliance with this court.

IT IS FURTHER ORDERED that if fines against Hubacek accrue to \$25,000, then upon a motion from the government, this court will incarcerate Hubacek until he files a certificate of compliance to all requirements of the permanent injunction and pays all fines imposed.
