The defendant having waived in open court prosecution by indictment, the United States

Attorney for the District of New Jersey charges:

## Willful Subscription to a False Tax Return 26 U.S.C. § 7206(1)

- 1. At all times relevant to this Information, defendant Lucille Abrahamsen Jackson, a resident of Hillsdale, New Jersey, had a financial interest in, and signature and other authority over, at least one financial account, having an aggregate value exceeding \$10,000, at UBS AG, a bank in Switzerland.
- 2. On or about July 5, 2007, defendant Lucille Abrahamsen Jackson signed, filed, and caused to be filed with the Internal Revenue Service ("IRS") a United States Individual Income Tax Return, IRS Form 1040 for calendar year 2005.
- 3. The tax return was signed by defendant Lucille Abrahamsen Jackson and contained a written declaration that it was signed under the penalties of perjury.
- 4. The tax return was not true and correct as to every material matter in that the tax return included false items, to wit: (a) on Schedule B, Part III, line 7a of the 2005 tax return, defendant Lucille Abrahamsen Jackson failed to report that she had an interest in and signature and other authority over a financial account at UBS AG in Switzerland; and (b) on Line 22 of the Form 1040 of the 2005 tax return, defendant Lucille Abrahamsen Jackson under-reported her total income by omitting income earned on her UBS AG Swiss bank account.

5. On or about July 5, 2007, in the District of New Jersey, and elsewhere, defendant

#### LUCILLE ABRAHAMSEN JACKSON

did knowingly and willfully make and subscribe to a United States Individual Income Tax Return, IRS Form 1040, as described in paragraphs 2 and 3, which she did not believe to be true and correct as to every material matter, as described in paragraph 4.

In violation of Title 26, United States Code, Section 7206(1).
