Moore was in prison when he was indicted on drug trafficking and murder charges on May 8, 2007. The federal Indictment charged him with being a part of the “Morales Organization,” and with murdering Pedro “Caco” Cruz in April 2001 on the orders of Raymond Morales, in furtherance of that Organization.

On December 20, 2007, Moore pleaded guilty before Judge Irenas to one count of conspiracy to distribute and possess with the intent to distribute cocaine and crack cocaine, and one count of murder (the Cruz murder) in furtherance of drug trafficking by using a firearm.

Raymond Morales, a drug kingpin, was arrested in March 2003 for drug-trafficking and subsequently began cooperating with law enforcement authorities. The Morales Organization operated in Camden from about 1993 to 2004. The Organization controlled a drug set at Atlantic and Norris Streets and also wholesaled kilograms of cocaine to other drug dealers and drug-trafficking organizations. Morales ordered a number of murders, which were carried out in furtherance of that Organization. To date, Morales’s cooperation has led to the convictions of over 20 high-level drug dealers, mostly in the Camden area, and the convictions of four people for drug-related murders.

Moore cooperated with the federal government and testified during two lengthy trials against three other men who murdered people on Morales’s orders: Jevon Lewis, a/k/a “V,” “Cool V,” and “Vaughn”; Ahmed Judge, a/k/a “Edy” and “Bleek”; and Juan Rivera-Velez, a/k/a “Two Face” and “Junito,” all of Camden. In March 2008, Lewis and Judge were convicted of the murder of Kenneth Fussell. In November 2009, Rivera-Velez was convicted of the murder of Miguel “Ito” Batista. The prosecution later showed that Fussell, an innocent man, was killed after he was incorrectly identified as a person who had crossed the Morales Organization. Lewis and Judge were sentenced to life imprisonment; Rivera-Velez is awaiting sentencing. All three men also were convicted of participating in the Morales drug-trafficking conspiracy.

In sentencing defendant Moore, Judge Irenas recognized a need to reward cooperation and send a message to the community about the importance of cooperating with the government. Law enforcement authorities depend on citizens and convicted criminals to cooperate in order to investigate and prosecute criminal activity. Judge Irenas noted that if Moore had not cooperated he would have faced a potential sentence of 30 years to life.

In determining the sentence, Judge Irenas consulted the advisory U.S. Sentencing Guidelines, which provide appropriate sentencing ranges that take into account the severity and characteristics of the offense, the defendant's criminal history, if any, and other factors. The judge, however, was not bound by those guidelines in determining a sentence.

Parole has been abolished in the federal system. Defendants who are given custodial terms must serve nearly all that time.

Fishman credited Special Agents of the DEA, under the direction of Special Agent in Charge Gerard P. McAleer, in Newark, and Investigators with the Camden County Prosecutor's Office Homicide Unit, under the direction of Camden County Prosecutor Warren W. Faulk, along with member agencies of the Philadelphia/Camden HIDTA Task Force and ATF Philadelphia Division, under the direction of Special Agent in Charge Mark Potter, with developing the investigation which resulted in the various Indictments.

Faulk, along with member agencies of the Philadelphia/Camden HIDTA Task Force and ATF Philadelphia Division, under the direction of Special Agent in Charge Mark Potter, with developing the investigation which resulted in the various Indictments.

The Philadelphia/Camden HIDTA Task Force comprises the U.S. Attorneys' Offices for the Districts of New Jersey and Eastern Pennsylvania, The Camden County Prosecutor's Office, Philadelphia District Attorney's Office, DEA, FBI, ATF, Camden Police Department, New Jersey State Police, Philadelphia Police Department, New Jersey Division of Criminal Justice, Pennsylvania Attorney General's Office, Camden County Sheriff's Department, Delaware River Port Authority Police and the U.S. Marshal's Service.

The government is represented by Assistant U.S. Attorneys Diana Vondra Carrig and Howard Wiener of the U.S. Attorney's Office Criminal Division in Camden.
