The United States Attorney charges:

1. In or about January 2009, in the Southern District of New York, JONATHAN FELIZ, a/k/a "Sweet Pea," a/k/a "Snoop," the defendant, during and in relation to a drug trafficking crime for which he may be prosecuted in a court of the United States, namely, the narcotics trafficking offense charged in Count Ten of Indictment No. S10 09 Cr. 195 (GBD) currently pending in the Southern District of New York, did knowingly use and carry firearms, and, in furtherance of such crime, did knowingly possess firearms, and did aid and abet the use, carrying, and possession of firearms, including a Smith & Wesson .357 Magnum revolver; two Taurus 9-millimeter handguns; a Smith and Wesson 9millimeter handgun; and an H&R .32 caliber revolver.

COUNT TWO

The United States Attorney further charges:

2. In or about November 2006, in the Southern District of New York, JONATHAN FELIZ, a/k/a "Sweet Pea," the defendant, during and in relation to a crime of violence for which he may be prosecuted in a court of the United States, namely, Racketeering Act One of the racketeering offense charged in Count One of Indictment No. S10 09 Cr. 195 (GBD) currently pending in the Southern District of New York, did knowingly use and carry firearms, and, in furtherance of such crime, did knowingly possess firearms, and did aid and abet the use, carrying, and possession of firearms, including handguns that were discharged at victims on or about September 25, 2006, and November 23, 2006.
