1 Q: Can you please state your full name for the record? 2 A: Yes. Lorraine Pollice. 3 0: What is your business address? 4 A. The Council for Tobacco Research-U.S.A., Inc., 122 East 42nd Street, New 5 York, New York 10168. 6 Q: I am going to refer to your employer, The Council for Tobacco Research-7 U.S.A., Inc., as "CTR." Is that acceptable to you? 8 A: Yes. 0: Ms. Pollice, what is your current position with CTR? 10 A: Currently, I am corporate secretary and treasurer. 11 Q: What are your daily duties you perform in your capacity as corporate 12 secretary and treasurer? 13 I draw and sign all checks covering payments and I maintain all financial A: 14 records. I also do some administrative work on the company's trust, which includes medical 15 benefits for CTR's retirees. I assist our accountants who visit our office yearly. I assist the 16 attorneys by providing them information needed in litigation related matters as requested. I also 17 answer phones and do general secretarial work. Ms. Pollice, when did you first begin your employment with CTR? 18 Q: 19 1975. A: 20 Q: What position did you hold in 1975 when you started with CTR? 21 A: I was secretary to Dr. Hockett and Dr. Stone. 22 O: And what position did Dr. Hockett hold at that time? 23 A: Dr. Hockett was research director of CTR. 24 0: What position did Dr. Stone hold at that time? 25 A: Dr. Stone was associate research director of CTR.

1 Q: What were your major responsibilities in that position at that time? 2 A: I sent out research applications to the CTR Scientific Advisory Board (SAB) 3 for review and did general secretarial work. 4 O: What was your next position with CTR? 5 Α. In 1981, I was secretary to Mr. Hoyt and Mr. Gertenbach and assistant treasurer of CTR. 6 7 Q: What was Mr. Hoyt's position at that time? 8 A: Mr. Hoyt was executive vice president. 9 O: What was Mr. Gertenbach's position at that time? 10 A: He was vice president. 11 Q: What were your major responsibilities at that time? 12 A: I drew and signed all checks for CTR and approved all payments made by 13 CTR. I also performed secretarial duties. 14 Q: What was your next position with CTR? 15 A: In 1984, I became corporate secretary of CTR. 16 Q: What were your major job responsibilities in that position? 17 A: I was responsible for attending CTR Board of Directors Meetings and CTR 18 annual meetings of members and taking the minutes of those meetings. 19 Q: What was your next position with CTR? In 1991, I became assistant treasurer and secretary of CTR. 20 A: 21 Q: What were your major job responsibilities in that position? 22 A: In addition to my duties as corporate secretary, I was responsible for preparing 23 the annual budget for Dr. Glenn. 24 O: In 1975, when you first began your employment with CTR, approximately 25 how many employees worked at CTR?

1	A:	Including CTR's Literature Retrieval Division (LRD), approximately between ten		
2	and fifteen employees.			
3	Q:	You just referenced CTR's Literature Retrieval Division. How did you		
4	interact with the literature retrieval division in your work for CTR?			
5	A:	CTR maintained the literature retrieval division's checking account, which was		
6	separate from CTR's general fund account. I drew and signed all checks for LRD for all			
7	approved vouchers and invoices at Mr. Gertenbach's direction. Also, at Mr. Hoyt and Mr.			
8	Gertenbach's request, I would type up and send out requests for funds to cover LRD.			
9	Q:	During what time period did you conduct these duties related to the LRD?		
10	A:	From approximately 1981 until early 1983 when LRD was spun off.		
11	Q:	Can you explain the process by which you dealt with invoices from LRD and		
12	wrote checks for those invoices?			
13	A:	We received the invoices from LRD for us to draw the checks. The invoices		
14	would go to Mr. Gertenbach and then to me. And then we would return the checks to LRD for			
15	mailing. I was responsible for requesting the funds and drawing the checks.			
16	Q:	From whom did you request the funds?		
17	A:	From the sponsoring companies of CTR.		
18	Q:	Can you name the sponsoring companies of CTR at that time?		
19	A:	I think Brown & Williamson Tobacco Corporation, Lorillard, Inc., Philip Morris		
20	Companies, Inc. and R.J. Reynolds Tobacco Company. There could be others that I can't			
21	presently recall.			
22	Q:	Did you request funds from the sponsoring companies on a regular basis?		
23	A:	Yes. Approximately quarterly or every three months.		
24	Q:	Who did you communicate with in LRD about your duties associated with		
25	LRD?			

1 A: I dealt with Marilyn Cato and Ms. Rodriguez. 2 O. Were the LRD employees also considered employees of CTR? 3 A. Yes. They were on the payroll and received benefits. They were employees 4 just like all of us were. 5 Q: You said earlier that The Literature Retrieval Division (LRD) was spun off from CTR in 1983, correct? 6 7 A: Yes. 8 0: How were you informed about LRD's separation from CTR? 9 A: I found out about LRD's separation because I assisted Mr. Gertenbach with 10 the spinning off of LRD. 11 Q: And what did the spinning off of LRD entail? 12 A: We had to separate LRD's payroll, retirement plan and medical plans from 13 CTR. We also had to close LRD's checking account. 14 0: Did you personally close the LRD checking account? 15 I do not recall. I know the account was closed but I don't remember if I Α. 16 personally was assigned to close the account. 17 O: Do you recall how the LRD checking account was set up or named? The Council For Tobacco Research- U.S.A., Inc. – literature retrieval division, 18 A: 19 special account number 1; I believe that is the way the account was referenced on the checks. 20 Q: In your role as secretary and later as secretary and treasurer of CTR, besides 21 attending CTR Board of Directors Meetings like you already mentioned, did you have any 22 additional responsibilities with respect to CTR Board of Directors Meetings? 23 A. Yes. 24 0: What were those responsibilities?

I sent out the notice of the CTR Board of Directors meetings. I also took

During the meetings, I would make hand-written notations on the agenda 8 for that meeting about what was discussed. 9 O: Once you recorded those notations on the agenda, did you formally type up 10 minutes for those meetings? 11 A: Yes. Sometimes I would run right back to my office and write them up and then 12 I would type them up. That's correct. Were the minutes formally approved by anyone? 13 0: 14 **A**: Yes. 15 Q: By whom were they approved? 16 A: From 1984 through the 1980's, Mr. Gertenbach would review the minutes. 17 O: Do you recall the minutes approval process for the 1990's? 18 A: Yes. In the 1990's, I would prepare the minutes for Dr. Glenn's review. After 19 Dr. Glenn's review, the minutes were sent to Debevoise & Plimpton for review. 20 Q: Were any changes made to the minutes once they were reviewed first by Dr. 21 Glenn and then by the attorneys? 22 A: Other than grammatical changes, none that I can recall. 23 0: If there were changes to be made, would you make those changes and then 24 re-circulate them for a second review? 25 No, I would just put the changes into the final form after advising Dr. Glenn of A:

Are you generally familiar with these 14 minutes? 15 Yes Α. 16 Was it the regular practice of CTR to make a record of the board of directors Q: 17 meetings in the form of meeting minutes? 18 A: Yes. 19 Were these minutes habitually prepared shortly after board of director 0: 20 meetings were held as you earlier indicated was the practice for preparing CTR Board of 21 **Directors Meeting minutes?** 22 A: Yes. Who wrote these minutes? 23 0: I did. 24 A: 25 Q: Is that your signature that appears at the end of each set of minutes
