Defendant did then and there, while having assumed the responsibility of caring for an older person, including the provision of food, shelter, clothing or services necessary to maintain the physical or mental health of that older person did fail to do so in the following manner:

Defendant, while operating a housing facility located at 3036 Holly Hill Avenue, Las Vegas, Nevada, knowingly left the facility without a properly authorized care giver present: thereby neglecting to provide proper oversight and protective services, when a fire broke out proximately causing the death of a facility resident K.R., a person over the age of sixty (60) vears.

All of which constitutes a Felony violation of NRS 200.5099(2) and (7), 200.5092(4).

Category D Felony - NRS 200.070, 200.090

Defendant did then and there, while operating a housing facility located at 3036 Holly Hill Avenue, Las Vegas, Nevada, unlawfully and feloniously kill Warren M., a human being, without any intent so to do in the commission of a lawful act in the following unlawful manner:

Defendant knowingly left the facility without a properly authorized care giver present. and without proper oversight services, when a fire broke out, proximately causing the death of a facility resident, Warren M.

All of which constitutes a Felony violation of NRS 200.070, 200.090.

All of which is contrary to the form, force and effect of the statutes in such cases made and provided against the peace and dignity of the State of Nevada.
