# EAGLE (Elder Abuse Guide for Law Enforcement)

EAGLE is a web module for law enforcement to better respond to elder abuse, quickly locate resources, and engage in training activities.

<u>NW3C EAGLE Online Training</u> is a course that covers the main features of the free tool, Elder Abuse Guide for Law Enforcement (EAGLE), while providing an introductory understanding of the role of law enforcement in elder abuse. IADLEST certified in 36 states.

<u>EAGLE Tactical Training</u> is a readymade curriculum for providing elder abuse training to law enforcement officers.

#### **Multidisciplinary Teams**

<u>The MDT Technical Assistance Center</u> provides consultations, resources, and training for newly forming and established elder abuse multidisciplinary teams.

#### **Interviewer Training**

SAFE (Safe Accessible Forensic Interviewing for Elders) Training Curriculum was developed to meet the growing need for trauma-informed, victim-centered interviewing techniques for use with older adults in criminal contexts. #### **Roll Call Videos**

Identifying and Responding to Elder Abuse: An Officer's Role is a series of six roll call videos designed by IACP for patrol officers to quickly recognize and respond to various types of elder abuse.

#### Tools

<u>SAFTA</u> (Senior Abuse Financial Tracking and Accounting Tool) is an easy-to-use tool that provides a simplified method for identifying suspicious financial patterns to facilitate the prosecution of financial exploitation.

#### **E-Learning**

<u>Elder Abuse Investigations Training for Law</u> <u>Enforcement and Other Investigators</u> is a series of 23 short, on-demand e-learning modules (developed by NCALL) offering law enforcement officers, investigators, and other first responders an opportunity to access training on a range of relevant elder abuse topics.

<u>NW3C Financial Crimes Against Seniors Seminar</u> is a 2-day live, online seminar that takes a multiagency approach to the financial exploitation of older adults (only offered at specified times). Inperson training may be available upon request.

Law Enforcement Webinars is a collection of on-demand webinars specifically developed for law enforcement detecting, responding to, and investigating forms of elder abuse.
