CREPPY, Appellate Immigration Judge

On February 26, 2024, the Attorney Discipline Board of Michigan suspended the respondent from the practice of law in Michigan for 180 days, effective March 19, 2024, and until further order of the Attorney Discipline Board. On March 20, 2024, the Attorney Discipline Board issued a Notice of Suspension and Restitution with Condition finalizing the respondent's 180-day suspension and the effective date of March 19, 2024. On June 13, 2024, the Disciplinary Counsel for the Executive Office for Immigration Review and the Disciplinary Counsel for the Department of Homeland Security ("DHS") jointly petitioned for the respondent's immediate suspension from practice before the Board of Immigration Appeals, the Immigration Courts, and DHS. The petition will be granted.¹ See 8 C.F.R. §§ 1003.103(a)(1) and (4) (discussing grounds for immediate suspension).

ORDER: The petition is granted, and the respondent is hereby suspended from the practice of law before the Board of Immigration Appeals, the Immigration Courts, and DHS pending final disposition of this proceeding. 8 C.F.R. § 1003.103(a)(4).

FURTHER ORDER: The respondent shall promptly notify, in writing, any clients with cases currently pending before the Board of Immigration Appeals, the Immigration Courts, or DHS that the respondent has been suspended from practicing before these bodies.

¹ Upon good cause shown, the Board of Immigration Appeals may set aside the order of immediate suspension when it appears in the interest of justice to do so. 8 C.F.R. § 1003.103(a)(4).
