CREPPY, Appellate Immigration Judge

On January 6, 2025, the Supreme Court of California issued an order suspending the respondent from the practice of law in California for one year, staying the execution of that period of suspension, and placing the respondent on probation subject to conditions, including the condition that the respondent is suspended for the first 60 days of probation, effective February 5, 2025. On January 28, 2025, the Disciplinary Counsel for the Executive Office for Immigration Review and the Disciplinary Counsel for the Department of Homeland Security ("DHS") jointly petitioned for the respondent's immediate suspension from practice before the Board of Immigration Appeals, the Immigration Courts, and DHS, effective February 5, 2025. The petition will be granted.

See 8 C.F.R. § 1003.103(a)(1) and (4) (discussing grounds for immediate suspension).

ORDER: The petition is granted, and the respondent is hereby suspended from the practice of law before the Board of Immigration Appeals, the Immigration Courts, and DHS, effective February 5, 2025, pending final disposition of this proceeding. 8 C.F.R. § 1003.103(a)(4).

FURTHER ORDER: The respondent shall promptly notify, in writing, any clients with cases currently pending before the Board of Immigration Appeals, the Immigration Courts, or DHS that the respondent has been suspended from practicing before these bodies.

¹ Upon good cause shown, the Board of Immigration Appeals may set aside the order of immediate suspension when it appears in the interest of justice to do so. 8 C.F.R. § 1003.103(a)(4).
