ORDER

Pursuant to the Rules of Professional Conduct, 8 C.F.R. §§ 1003.102(e)(1) and 1003.106(b), Respondent is hereby suspended from the practice of law before the Board of Immigration Appeals, the Immigration Courts, and the Department of Homeland Security, for a period of one (1) year, effective March 30, 2004. This period of suspension runs concurrent with the suspension imposed upon Respondent by the New York Supreme Court, Appellate Division, Third Judicial Department. Respondent may seek reinstatement under the restrictions set forth in 8 C.F.R. §1003.107 provided that, at the time of the filing of the reinstatement petition, Respondent meets the definition of attorney at 8 C.F.R. §1.1(f).

Respondent has the right to appeal this decision to the Board of Immigration Appeals pursuant to 8 C.F.R. § 1003.106(c). A notice of appeal must be filed in accordance with all pertinent provisions for appeals to the Board, including provision relating to forms and fees, as set forth in 8 C.F.R. Part 3.
