**INDICTMENT**

**COUNTS ONE TO TWENTY**

**THE GRAND JURY CHARGES THAT:**

On or about the dates listed below, each date constituting a separate count, in the Eastern District of Pennsylvania, and elsewhere, the defendant,

**JOHN CORCORAN IV,**

employed, used, persuaded, induced, enticed, and coerced, and attempted to employ, use, persuade, induce, entice, and coerce the minors below listed in each count to engage in sexually explicit conduct for the purpose of producing a visual depiction of that conduct, and defendant CORCORAN knew and had reason to know that the visual depiction was produced or transmitted using materials that have been mailed, shipped, or transported in or affecting interstate or foreign commerce by any means:

**COUNT TWENTY-ONE**

**THE GRAND JURY FURTHER CHARGES THAT:**

On or about December 12, 2014, in Glenolden, in the Eastern District of Pennsylvania, defendant

**JOHN CORCORAN IV,**

knowingly possessed books, magazines, periodicals, films, video tapes and other matter, namely a Compaq computer, an LG Smart phone, and a Blackberry cell phone, which contained visual depictions that had been shipped or transported using any means or facility of interstate or foreign commerce, or in or affecting interstate or foreign commerce, that is, the Internet. The production of these visual depictions involved the use of a minor engaging in sexually explicit conduct and the visual depictions were of minors engaging in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(4)(B).

**NOTICE OF FORFEITURE**

**THE GRAND JURY FURTHER CHARGES THAT:**

As a result of the violations of Title 18, United States Code, Sections 2251(a), and 2252(a)(4), as set forth in this indictment, defendant

**JOHN CORCORAN IV,**


shall forfeit to the United States of America any property used or intended to be used, in any manner or part, to commit, or to facilitate the commission of, the violations of Title 18, United States Code, Sections 2251(a), and 2252(a)(4), as charged in this indictment, including, but not limited to:

1. One Compaq Presario SR1750NX computer, serial number CNN55212PL;
2. One LG 840 Smart phone, serial number 204KPUU0011166 with micro SD card; and
3. One Blackberry 8330 cell phone, MEID: A000000DAD9998 with micro SD card.

All pursuant to Title 18, United States Code, Section 2253.
