

Executive Grant of Clemency

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS **DANIELA GOZES-WAGNER, AKA DANIELA WAGNER, DANIELA MAYER GOZES, AND DANIELA GOZES**, Reg. No. 80867-379, was convicted, in the United States District Court for the Southern District of Texas on a superseding indictment (Docket No. 4:14CR00637-004) of violations of Sections 1349 and 1956(h), Title 18, United States Code, for which a total sentence of 240 months' imprisonment, three years' supervised release, \$15,283,985 restitution, and a \$200 special assessment was imposed on March 6, 2019; and

WHEREAS the said **DANIELA GOZES-WAGNER** has been confined continuously since the jury sitting in the United States District Court for the Southern District of Texas returned verdict on September 28, 2017, and is presently incarcerated at the Federal Correctional Institution – Danbury in Danbury, Connecticut; and

WHEREAS it has been made to appear that the ends of justice do not require the said **DANIELA GOZES-WAGNER** to remain confined until her currently projected release date of October 7, 2034, and the safety of the community will not be compromised if she is released;

NOW, THEREFORE, BE IT KNOWN that I, **DONALD J. TRUMP**, President of the United States of America, in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby grant clemency to the said **DANIELA GOZES-WAGNER**: I commute the prison sentence imposed upon the said **DANIELA GOZES-WAGNER** to time served. I further remit the remaining unpaid balance of the \$15,283,985 restitution obligation imposed upon the said **DANIELA GOZES-WAGNER** and leave intact and in effect the three-year term of supervised release with all its conditions, and all other components of the sentence.

I HEREBY DESIGNATE, direct, and empower, the Acting Pardon Attorney, as my representative, to deliver to the Bureau of Prisons, to the United States District Court for the Southern District of Texas, and to the said **DANIELA GOZES-WAGNER** a certified copy of this document as evidence of my action in order to carry into effect the terms of this grant.

I **ALSO DIRECT** the Bureau of Prisons, upon receipt of this warrant, to effect the immediate release of the said **DANIELA GOZES-WAGNER** with all possible speed.
