

# Executive Grant of Clemency

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

*WHEREAS* **KWAME MALIK KILPATRICK**, Reg. No. 44678-039, was convicted, in the United States District Court for the Eastern District of Michigan on a superseding indictment (Docket No. 10CR20403-1) of violations of Sections 666(a), 666(a)(B)(2), 1341, 1343, 1951, 1951(b)(2), 1962(d), and 1963(a), Title 18 and Sections 7201(1) and 7206(1), Title 26, United States Code, for which a total sentence of 336 months' imprisonment, three years' supervised release, \$4,779,826.61 restitution, and a \$2,400 special assessment was imposed on October 10, 2013; and

*WHEREAS* the said **KWAME MALIK KILPATRICK** has been confined continuously since the jury sitting in the United States District Court for the Eastern District of Michigan returned verdict on March 11, 2013, and is presently incarcerated at the Federal Correctional Institution – Oakdale I in Oakdale, Louisiana; and

*WHEREAS* it has been made to appear that the ends of justice do not require the said **KWAME MALIK KILPATRICK** to remain confined until his currently projected release date of January 18, 2037, and the safety of the community will not be compromised if he is released;

NOW, THEREFORE, BE IT KNOWN that I, **DONALD J. TRUMP**, President of the United States of America, in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby grant clemency to the said **KWAME MALIK KILPATRICK**: I commute the prison sentence imposed upon the said **KWAME MALIK KILPATRICK** to time served. I leave intact and in effect the remaining unpaid balance of the \$4,779,826.61 restitution obligation, the special assessment of \$2,400, the three-year term of supervised release with all its conditions, and all other components of the sentence.


**I HEREBY DESIGNATE**, direct, and empower, the Acting Pardon Attorney, as my representative, to deliver to the Bureau of Prisons, to the United States District Court for the Eastern District of Michigan, and to the said **KWAME MALIK KILPATRICK** a certified copy of this document as evidence of my action in order to carry into effect the terms of this grant.

**I ALSO DIRECT** the Bureau of Prisons, upon receipt of this warrant, to effect the immediate release of the said **KWAME MALIK KILPATRICK** with all possible speed.
