On the record statement, attributed to Sarah Isgur Flores:

There was absolutely nothing misleading about his answer. Last year, the Senator had over 25 conversations with foreign ambassadors as a senior member of the Armed Services Committee, including the British, Korean, Japanese, Polish, Indian, Chinese, Canadian, Australian, German and Russian ambassadors. He was asked during the hearing about communications between Russia and the Trump campaign--not about meetings he took as a senator and a member of the Armed Services Committee.

On background regarding the office visits by ambassadors:

He met with the ambassadors in his capacity as a senator on the Armed Services Committee, and they discussed relations between the two countries and any positive or negative issues they were facing. During 2016, ambassadors would often make superficial comments about election-related news, but it was not the substance of their discussion.

On background regarding the Heritage Foundation speech encounter:

After speaking to the group of 50-plus ambassadors, a small group of ambassadors approached the Senator as he was leaving the stage. The Russian ambassador was among them. He spoke to them while they stood together as a group. The ambassadors expressed appreciation for his remarks and made invitations for the Senator to join them at various events they were sponsoring. He made no commitments.
