TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

*WHEREAS* **CLARENCE AARON** was convicted in the United States District Court for the Southern District of Alabama on an indictment (Docket No. 1:93CR00008-003) charging violation of Sections 846 and 841(a)(1), Title 21, United States Code, for which a sentence of life imprisonment, five years' supervised release, and a special assessment of one hundred fifty dollars (\$150.00) was imposed on December 10, 1993; and

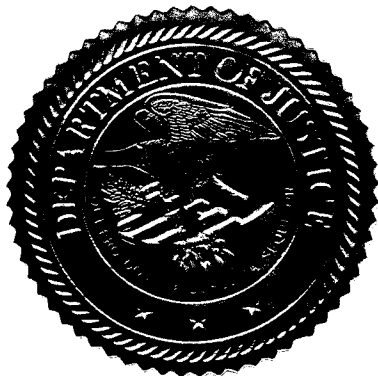


