Executive Grant of Clemency

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS **DWIGHT LINCOLN HAMMOND, JR.**, Reg. No. 59886-065, was convicted, in the United States District Court for the District of Oregon on a superseding indictment (Docket No. 6:10 CR 60066-2-AA), of violation of Sections 2 and 844(f)(1), Title 18, United States Code, for which a total sentence of 60 months' imprisonment and three years' supervised release was imposed on October 30, 2012, as amended on October 7, 2015; and

WHEREAS said **DWIGHT LINCOLN HAMMOND**, **JR.**, Reg. No. 59886-065, has been confined continuously since he self-surrendered on January 4, 2016, having previously served a portion of the sentence, and is presently incarcerated at the Federal Correctional Institution – Terminal Island in San Pedro, California; and

WHEREAS it has been made to appear that the ends of justice do not require the said **DWIGHT LINCOLN HAMMOND, JR.**, Reg. No. 59886-065, to remain confined until his currently projected release date of February 13, 2020, and the safety of the community will not be compromised if he is released:

NOW, THEREFORE, BE IT KNOWN that I, **DONALD J. TRUMP**, President of the United States of America, in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby grant clemency to the said **DWIGHT LINCOLN HAMMOND**, **JR.**, Reg. No. 59886-065. I commute the prison sentence imposed upon the said **DWIGHT LINCOLN HAMMOND**, **JR.**, Reg. No. 59886-065, to time served. I also commute the entirety of the three-year term of supervised release with all its conditions and all other components of the sentence.

I HEREBY DESIGNATE, direct, and empower, the Acting Pardon Attorney, as my representative, to deliver to the Bureau of Prisons, to the United States District Court for the District of Oregon, and to the said DWIGHT LINCOLN HAMMOND, JR., Reg. No. 59886-065, a certified copy of this document as evidence of my action in order to carry into effect the terms of this grant.

I ALSO DIRECT the Bureau of Prisons, upon receipt of this warrant, to effect immediately the release of the said DWIGHT LINCOLN HAMMOND, JR., Reg. No. 59886-065.
