

Executive Grant of Clemency

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS **JUDITH NEGRON**, Reg. No. 95719-004, was convicted, in the United States District Court for the Southern District of Florida on an indictment (Docket No. 1:10-20767-CR-KING(s)-003) of violations of Sections 371, 1347, 1349, 1956(a)(1)(B)(I), 1956(h), and 1957, Title 18, and Sections 5324(a)(1) and 5324(d)(20), Title 31, United States Code, for which a total sentence of 35 years' imprisonment; three years' supervised release; eighty-seven million, five hundred thirty-three thousand, eight hundred sixty-three dollars, and forty-six cents (\$87,533,863.46) restitution; and a special assessment of two thousand four hundred dollars (\$2,400) (mistakenly set forth in the amended judgement as \$24,00.00) was imposed on December 8, 2011; and

WHEREAS the said **JUDITH NEGRON** has been confined continuously since the pronouncement of sentence by the United States District Court for the Southern District of Florida on December 8, 2011, and is presently incarcerated at the Federal Correctional Institution - Coleman Low in Sumterville, Florida; and

WHEREAS it has been made to appear that the ends of justice do not require the said **JUDITH NEGRON** to remain confined until her currently projected release date of February 9, 2042, and the safety of the community will not be compromised if she is released;

NOW, THEREFORE, BE IT KNOWN that I, **DONALD J. TRUMP**, President of the United States of America, in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby grant clemency to the said **JUDITH NEGRON**: I commute the prison sentence imposed upon the said **JUDITH NEGRON** to time served. I leave intact and in effect the remaining unpaid balance of the \$87,533,863.46 restitution, the special assessment of two thousand four hundred dollars (\$2,400), the three-year term of supervised release with all its conditions, and all other components of the sentence.

I HEREBY DESIGNATE, direct, and empower, the Office of the Pardon Attorney, as my representative, to deliver to the Bureau of Prisons, to the United States District Court for the Southern District of Florida, and to the said **JUDITH NEGRON** a certified copy of this document as evidence of my action in order to carry into effect the terms of this grant.


