The Grand Jury charges:

FIRST COUNT:

On or about July 21, 2024, within the District of Columbia, Ankintola K. Olowofoyeku assaulted Erick Blanco with a dangerous weapon, that is, a knife. (Assault with a Dangerous Weapon, in violation of 22 D.C. Code, Section 402 (2001 ed.))

*The Grand Jury further charges that at the time Ankintola K. Olowofoyeku committed the crime of violence set forth in this Count against Erick Blanco, Erick Blanco was traveling on a mass transit vehicle within the District of Columbia. (Crime of Violence Committed Against a Mass Transit Passenger, in violation of 22 D.C. Code Section 3751.01(a-1) (2001 ed.))*

*(Assault with a Dangerous Weapon, Crime of Violence Committed Against a Mass Transit Passenger (Post March 12, 2024), in violation of 22 D.C. Code, Section 402, 3751.01(a-1) (2001 ed.))*

## SECOND COUNT:

On or about July 21, 2024, within the District of Columbia, Ankintola K. Olowofoyeku assaulted Keion Dorvilier with a dangerous weapon, that is, a knife. (Assault with a Dangerous Weapon, in violation of 22 D.C. Code, Section 402 (2001 ed.))

*The Grand Jury further charges that at the time Ankintola K. Olowofoyeku committed the crime of violence set forth in this Count against Keion Dorvilier, Keion Dorvilier was traveling on a mass transit vehicle within the District of Columbia. (Crime of Violence Committed Against a Mass Transit Passenger, in violation of 22 D.C. Code Section 3751.01(a-1) (2001 ed.))*

*(Assault with a Dangerous Weapon, Crime of Violence Committed Against a Mass Transit Passenger (Post March 12, 2024), in violation of 22 D.C. Code, Section 402, 3751.01(a-1) (2001 ed.))*

## THIRD COUNT:

On or about July 21, 2024, within the District of Columbia, Ankintola K. Olowofoyeku, while armed with and having readily available a dangerous and deadly weapon that is a knife, unlawfully assaulted and threatened Erick Blanco in a menacing manner and intentionally, knowingly, and recklessly caused significant bodily injury to Erick Blanco. (Assault with Significant Bodily Injury While Armed, in violation of 22 D.C. Code, Section 404 (a)(2), 4502 (2001 ed.))

*The Grand Jury further charges that at the time Ankintola K. Olowofoyeku committed the crime of violence set forth in this Count against Erick Blanco, Erick Blanco was traveling on a mass transit vehicle within the District of Columbia. (Crime of Violence Committed Against a Mass Transit Passenger, in violation of 22 D.C. Code Section 3751.01(a-1) (2001 ed.))*

*(Assault with Significant Bodily Injury, Crime of Violence Committed Against a Mass Transit Passenger (Post March 12, 2024), in violation of 22 D.C. Code, Section 404 (a)(2), 3751.01(a-1) (2001 ed.))*

## FOURTH COUNT:

On or about July 21, 2024, within the District of Columbia, Ankintola K. Olowofoyeku threatened to injure and kidnap Erick Blanco. (Threatening To Injure/Kidnap a Person, in violation of 22 D.C. Code, Section 1810 (2001 ed.))

FIFTH COUNT:

On or about July 21, 2024, within the District of Columbia, Ankintola K. Olowofoyeku threatened to injure and kidnap Keion Dorvilier. (Threatening To Injure/Kidnap a Person, in violation of 22 D.C. Code, Section 1810 (2001 ed.))
