The Grand Jury charges that:

COUNT 1

On or about April 19, 2018, in the Eastern District of Louisiana, the defendant, **OSCAR LOPEZ-GUERRERO, a/k/a Jamie Lozano Ceja**, an alien, was found in the United States after having been deported and removed therefrom on July 31, 2014, without the Attorney General of the United States or his designated successor, the Secretary of the Department of Homeland Security, as provided for in Title 6, United States Code, Section 202(3) and (4), and 557, having expressly consented to the defendant's reapplication for admission into the United States; all in violation of Title 8, United States Code, Section 1326(a).

NOTICE OF SENTENCE ENHANCEMENT


Now comes the United States of America, by and through Duane A. Evans, the United States Attorney for the Eastern District of Louisiana, to give notice that the defendant, **OSCAR LOPEZ-GUERRERO, a/k/a Jamie Lozano Ceja**, was previously convicted of a felony on March 10, 2008, in the Superior Court of Arizona, Pima County, Tucson, Arizona, case number CR20074793, for violating Arizona R.S. Sections 13-1001 and 13-3408, to wit: Attempted Sale and/or Transfer of Heroin. Because of this felony conviction, if the defendant is convicted for a violation of Title 8, United States Code, Section 1326(a), the defendant's sentence will be subject to a maximum sentence of imprisonment for not more than 20 years. Title 8, United States Code, Section 1326(b)(2).
