In honor of National Crime Victims' Rights Week, this year's event will feature a message of hope and inspiration from caretakers in a child exploitation case. An elementary school child disclosed being sexually abused for two years by a trusted person who had been close to the family. When confronted, the offender admitted to the abuse and the production of child sexual abuse materials. The investigation revealed that the offender had victims dating back several decades and was prosecuted federally for production of child pornography and was sentenced to 30 years imprisonment. During this commemorative event, the caretakers will courageously share their powerful story of resilience, strength, and recovery from victimization in the hope of raising awareness for others and preventing future abuse.

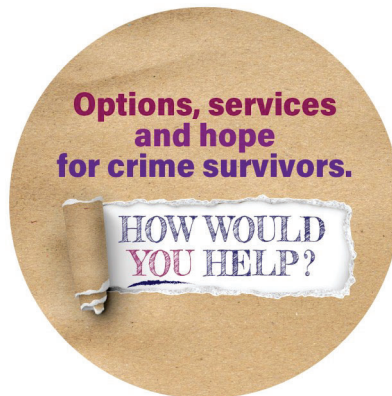

State Archives of North Carolina 109 E. Jones St. Raleigh, NC 27601

The State Archives of North Carolina is located in downtown Raleigh between the North Carolina General Assembly and the North Carolina Executive Mansion at 109 East Jones Street. The event will be held in the Auditorium.

State Archives of North Carolina Guidance

- I.D. badges must be worn at all times.
- A building entrance ramp for wheelchairs is located at the east end of the building.
- Restrooms are located just outside the auditorium.
- Smoking, eating and drinking are **PROHIBITED** in the auditorium.

Directions

From the North

Take U.S. 1 South and follow the Capitol Blvd. (downtown) designation. Turn left on to Jones Street and the State Archives of North Carolina is located between Wilmington Street and Blount Street.

From the Raleigh-Durham International Airport, take Glenwood Ave. (U.S. 70) into downtown. Turn left on to Jones Street and the State Archives of North Carolina is on the right, between Wilmington Street and Blount Street.

From the East

Take U.S. 64 West on New Bern Ave. (which changes to Edenton St). Turn right onto Person Street for one block, turn left onto East Jones Street for one block, and the State Archives of North Carolina is on the right, between Wilmington Street and Blount Street.

From I-40, take exit 299 (Person St) Proceed north for two miles. Turn left on to East Jones Street for one block and the State Archives of North Carolina is on the right between Wilmington Street and Blount Street.

From U.S. 70 East, take I-40 to exit 299 (Person St.) and turn left on to East Jones Street. for one block and the State Archives of North Carolina is on the right between Wilmington Street and Blount Street.

From the West

From I-40 East, take exit 289 (Wade Ave.) to Capitol Blvd. Continue on Capitol Blvd. and turn left on to East Jones Street and the State Archives of North Carolina is on the right between Wilmington Street and Blount Street.

From the South

From U.S. 64 East or U.S. 1 North, take Western Blvd. turn left on to Wilmington Street turn right onto East Jones Street and the State Archives of North Carolina is on the left between Wilmington Street and Blount Street.

Parking

Paid parking is available in the lot directly across the street from the State Archives of North Carolina. During the week, the rate for parking is \$2.00 an hour. Metered parking is also available on East Jones and Edenton.
