#### **COUNT ONE**

The SPECIAL JULY 2021 GRAND JURY charges:

On or about August 7, 2021, at Frankfort, in the Northern District of Illinois, Eastern Division, and elsewhere,

defendant herein, knowingly possessed material, namely, a black Samsung model S20 FE 5G cellular phone with IMEI 359823613628991, that contained an image of child pornography, as defined in Title 18, United States Code, Section 2256(8)(A), involving a prepubescent minor and a minor who had not attained 12 years of age, such image having been shipped and transported in interstate and foreign commerce by any means, and such image having been produced using materials that had been shipped and transported in interstate and foreign commerce by any means, including by computer;

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2252A(b)(2).

## **COUNT TWO**

The SPECIAL JULY 2021 GRAND JURY further charges:

On or about October 17, 2021, at Frankfort, in the Northern District of Illinois, Eastern Division, and elsewhere,

defendant herein, did knowingly transport and cause to be transported, child pornography, as defined in Title 18, United States Code, Section 2256(8)(A), including, file name 34b1b78c-1242-4b98-84eb-c698b84c3555.mp4, using a means and facility of interstate and foreign commerce, and in and affecting interstate and foreign commerce by any means, including by computer;

In violation of Title 18, United States Code, Sections 2252A(a)(1) and 2252A(b)(1).

## **FORFEITURE ALLEGATION**

The SPECIAL JULY 2021 GRAND JURY further alleges:

Section 2252A as set forth in this Indictment, defendant shall forfeit to the United States of America any matter which contains visual depictions described in Title 18,

Upon conviction of an offense in violation of Title 18, United States Code,

United States Code, Section 2252A, and any property used and intended to be used

to commit and to promote the commission of such offense, as provided by Title 18,

United States Code, Section 2253(a).

2. The property to be forfeited includes, but is not limited to, the following

specific property: a black Samsung model S20 FE 5G cellular phone with IMEI
