I N F O R M A T I O N

The defendant having waived in open court prosecution by Indictment, the United States Attorney for the District of New Jersey charges:

Between in or about September 2022 and in or about February 2023, in Cape May County, in the District of New Jersey and elsewhere, the defendant,

AUSTIN T. MAHAN,

being a United States Postal Service Employee, did use, convert to his own use, and exchange for other property, without authority, money and property that came into his hands and under his control in any manner, namely, over \$1,000 in Postal Service funds, in the execution and under color of his office, employment, and service.

In violation of Title 18, United States Code, Section 1711 and Section 2.

FORFEITURE ALLEGATION

1. As a result of committing the offense charged in this Information, defendant AUSTIN T. MAHAN shall forfeit to the United States, pursuant to 18 U.S.C. § 981(a)(1)(C), all property, real or personal, constituting or derived from proceeds traceable to the offense charged in this Information, the value of which totaled \$54,355.83.

SUBSTITUTE ASSETS PROVISION

If any of the property described above, as a result of any act or omission of the defendant:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

the United States shall be entitled, pursuant to 21 U.S.C. § 853(p), as incorporated by 18 U.S.C. § 982(b)(1) and 28 U.S.C. § 2461(c), to forfeiture of any other property of the defendant up to the value of the above-described forfeitable property.
