INFORMATION

The defendant, having waived in open court prosecution by Indictment, the United States

Attorney for the District of New Jersey charges:

On or about March 17, 2023, in Atlantic County, in the District of New Jersey and elsewhere, the defendant,

ROBERT J. MOSER,

knowingly possessed destructive devices, as that term is defined in Title 26, United States Code, Sections 5845(a)(8) and 5845(f)(1), including:

- a destructive device more particularly described as an approximately 6½-inch cardboard tube, containing a quantity of an explosive mixture of potassium perchlorate and nitrate, as well as metal pieces, with a fuse sticking out of the device ("Object #1");
- a destructive device more particularly described as an approximately 4-inch cardboard tube, containing a quantity of an explosive mixture of perchlorate and nitrate, with a metal nail passing through the cardboard tube, a protruding metal screw hook, and a fuse sticking out of the device ("Object #2");
- a destructive device more particularly described as an approximately 4¾-inch cardboard tube, containing a quantity of an explosive mixture of perchlorate and

nitrate, with a protruding metal screw hook and a fuse sticking out of the device ("Object #3"); and

• a destructive device more particularly described as containing two pieces of a cardboard tube, an approximately 12-inch mortar tube, a plastic cup containing five metal dart tips, a lighter, layered tape, a quantity of an explosive mixture of perchlorate and nitrate, with a fuse sticking out of the device ("Object #4"),

which destructive devices were not registered to him in the National Firearms Registration and Transfer Record, as required by Title 26, United States Code 5841.

In violation of Title 26, United States Code, Sections 5861(d) and 5871.

FORFEITURE ALLEGATION

Upon conviction of the offense in violation of Title 26, United States Code, Sections 5861(d) and 5871, set forth in this Information, the defendant, ROBERT MOSER, shall forfeit to the United States, pursuant to Title 26, United States Code, Section 5872, any and all explosive devices involved in the commission of such offense, including, but not limited to, Object #1, Object #2, Object #3, and Object #4.
