**INDICTMENT**

The Grand Jury in and for the District of New Jersey, sitting at Newark, charges:

**COUNT ONE**

*(Drug Conspiracy)*

On or about March 5, 2021, in Essex County, in the District of New Jersey and elsewhere, the defendants,

**ALMARK ALSTON,  
a/k/a "Monster," and  
KAREEM GREEN,  
a/k/a "Try Me,"**

did knowingly and intentionally conspire and agree with each other and others to distribute and possess with intent to distribute a quantity of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance, and a quantity of a mixture and substance containing a detectable amount of fentanyl, a Schedule II controlled substance, contrary to Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C).

In violation of Title 21, United States Code, Section 846.

**COUNT TWO**

*(Distribution of Cocaine)*

On or about March 5, 2021, in Essex County, in the District of New Jersey and elsewhere, the defendants,

**ALMARK ALSTON,  
a/k/a “Monster,” and  
KAREEM GREEN,  
a/k/a “Try Me,”**

did knowingly and intentionally distribute a quantity of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C) and Title 18, United States Code, Section 2.

**COUNT THREE**

*(Possession with Intent to Distribute Cocaine and Fentanyl)*

On or about March 5, 2021, in Essex County, in the District of New Jersey and elsewhere, the defendants,

**ALMARK ALSTON,  
a/k/a “Monster,” and  
KAREEM GREEN,  
a/k/a “Try Me,”**

did knowingly and intentionally possess with intent to distribute a quantity of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance, and a quantity of a mixture and substance containing a detectable amount of fentanyl, a Schedule II controlled substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C) and Title 18, United States Code, Section 2.

**FORFEITURE ALLEGATIONS**

1. The allegations set forth in Counts One through Three of this Indictment are hereby realleged and incorporated by reference for the purpose of alleging forfeiture pursuant to Title 21, United States Code, Section 853.

2. Pursuant to Title 21, United States Code, Section 853, upon conviction of any of the controlled substance offenses alleged in Counts One through Three of this Indictment, the defendants,

**ALMARK ALSTON,  
a/k/a “Monster,” and  
KAREEM GREEN,  
a/k/a “Try Me,”**

shall forfeit to the United States of America any and all property constituting or derived from any proceeds the defendants obtained directly or indirectly as a result of these offenses, and any and all property used or intended to be used in any manner or part to commit and to facilitate the commission of these offenses.

**SUBSTITUTE ASSETS PROVISION**

If any of the property described above, as a result of any act or omission of the defendants:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

the United States shall be entitled, pursuant to Title 21, United States Code, Section 853(p), to the forfeiture of any other property of the defendants up to the value of the above-described forfeitable property.
