Between on or about March 1, 2024, and March 14, 2024, in Indian Country, in San Juan County, in the District of New Mexico, the defendant, **AVONDALE JOHNSON**, an Indian, did recklessly permit John Doe, a child under the age of eighteen, to be placed in a situation that may endanger life and health, and the defendant caused a substantial and unjustifiable risk of serious harm to the safety and health of John Doe.
