- ◆ **Who Should Attend:** Law enforcement officers, victim service providers, prosecutors, social workers, judges, physicians and other medical professionals, mental health therapists, counselors, educators, court service officers, corrections officers, child care providers, parents, community leaders, and other concerned individuals from the two-state region of North Dakota and South Dakota – especially those dealing with family violence issues in American Indian communities.
- ◆ **Registration:** There is no registration fee for this conference. However pre-registration is requested.
- ◆ **Registration deadline is September 11, 2015:** Registration after that date is on a space-available basis.
- ◆ **Resource Area:** Conference participants are encouraged to bring materials pertaining to their programs for the resource area. Call Beth Lang at (701) 530-2435 to reserve space.
- ◆ **Lodging:** Room blocks have been set aside at the Ramada Bismarck Hotel and Conference Center. Participants are responsible for their own lodging arrangements, except for scholarship recipients. (The U.S. Attorney's Office will make all scholarship lodging arrangements.)

The **United States Attorneys** from the Districts of **North Dakota and South Dakota** have received special funds from the U.S. Department of Justice, **Office for Victims of Crime**, to provide lodging scholarships for individuals from the two-state region who work with Native American victims of crime. These special funds are part of the Victims of Crime Act funds collected from convicted federal offenders.

Preference will be given to victim advocates, law enforcement, and other service providers who routinely work with Native American victims of crime and who are unable to attend the conference without financial assistance. Scholarship recipients must attend the entire conference.

Lodging scholarships will be for two nights, September 15 and September 16, 2015. The basic room rate will be paid by the Office for Victims of Crime. Scholarship recipients are responsible for all other charges such as telephone calls, room service, and movie rentals.

Scholarship lodging arrangements will be made by the U.S. Attorney's Office. The Ramada Bismarck Hotel and Convention Center is a Non-Smoking hotel.
