SOUTH DAKOTA CRIME VICTIMS' COMPENSATION PROGRAM

If you are an innocent victim of a violent crime or you have suffered physical injury as a result of:

- a criminal attack
- trying to stop a person committing a crime
- ² trying to help a law enforcement officer
- trying to help a victim of crime
- witnessing a violent crime

You may file a claim for compensation from the South Dakota Crime Victims' Compensation Program. However, not all crimes or expenses are covered. Compensation may be available for expenses incurred as a direct result of the criminal acts of another person. Examples of expenses covered under the law include:

- medical care
- rehabilitation
- ≅ work loss
- dental expenses
- mental health care

Property loss and pain and suffering are not compensable. The crime must have occurred on or after July 1, 1992, and must be reported to law enforcement within five days of its occurrence or when a report could have reasonably been made. Federal crime victims are eligible to apply for compensation whether or not the crime falls under tribal, state, or federal jurisdiction.

Emergency payments up to \$1,000 may be made under extraordinary circumstances if it is likely the victim/family would suffer undue hardship if payment were not forthcoming. An award may be made for immediate verifiable needs as a result of loss of income or support, emergency medical expenses, or funeral expenses. Maximum payment for any one claim is \$15,000.
