PENALTY CERTIFICATION

The undersigned Assistant United States Attorney hereby certifies that the maximum penalties for the offenses charged in the Indictment are as follows:

**Count 1: Conspiracy to Import and Distribute with Intent to Import a Controlled Substance (Eutylone and N,N-dimethylpentylone)  
21 U.S.C. § 963**

- Not more than twenty (20) years imprisonment
- Not more than a \$1,000,000.00 fine
- Not less than three (3) years nor more than life of supervised release
- \$100.00 special assessment

**Count 2: Conspiracy to Distribute and Possess with Intent to Distribute a Controlled Substance (Eutylone and N,N-dimethylpentylone)**

21 U.S.C. § 846

- Not more than twenty (20) years imprisonment
- Not more than a \$1,000,000.00 fine
- Not less than three (3) years nor more than life of supervised release
- \$100.00 special assessment

**Count 3: Distribution with Intent to Import a Controlled Substance (Eutylone and N,N-dimethylpentylone)**

21 U.S.C. § 959(a)

- Not more than twenty (20) years imprisonment
- Not more than a \$1,000,000.00 fine
- Not less than three (3) years nor more than life of supervised release
- \$100.00 special assessment

**Counts 4-5: Distribution of a Controlled Substance (N,N-dimethylpentylone)**

21 U.S.C. § 841(a)(1)

- Not more than twenty (20) years imprisonment
- Not more than a \$1,000,000.00 fine
- Not less than three (3) years nor more than life of supervised release
- \$100.00 special assessment
