Title 21, U.S.C., Secs. 841(a)(1) and 846 - Conspiracy to Distribute Methamphetamine; Title 21, U.S.C., Secs. 952, 960 and 963 -Conspiracy to Import Methamphetamine; Title 21, U.S.C., Secs. 952 and 960 - Importation of Methamphetamine; Title 21, U.S.C., Sec. 841(a)(1) - Possession of Methamphetamine with Intent to Distribute; Title 18, U.S.C., Sec. 2 - Aiding and Abetting; Title 18, U.S.C., Secs. 922(g)(1) and 924(a)(2) - Felon in Possession of a Firearm; Title 18, U.S.C., Sec. 924(d)(1), Title 28, U.S.C., Sec. 2461(c), and Title 21, U.S.C., Sec. 853 -Criminal Forfeiture

The grand jury charges:

#### Count 1

NGUYEN, aka Du, ISRAEL SOTO, aka Izzy, aka EZ, JAVIER CHAVEZ, VEOVANH INSIXENGMAY, aka Baby, ERIC ALLAN GUFFIN, aka White Boy, DIEN PHONG ROBERTS, TU, SENGNGUEN KOULAVONGSA, **JAMES** THUY THU VO, LOUIE aka Nquen, and ERIN LINDSAY CONNELLY, did knowingly and intentionally conspire with each other and with other persons known and unknown to the grand jury to distribute methamphetamine, a Schedule II Controlled Code, in violation of Title 21, United States Sections 841(a)(1) and 846.

#### Count 2

Beginning on a date unknown but at least as early as July 1, 2013, and continuing up to and including July 2, 2013, within the Southern District of California, and elsewhere, defendants DUNG VAN NGUYEN, aka Du, ISRAEL SOTO, aka Izzy, aka EZ, and SUZANA VERA, did knowingly and intentionally conspire with each other and with other

persons known and unknown to the grand jury to unlawfully import methamphetamine, a Schedule II Controlled Substance, into the United States from a place outside thereof; in violation of Title 21, United States Code, Sections 952, 960 and 963.

It is further alleged that the amount involved in the conspiracy attributable to defendants DUNG VAN NGUYEN, aka Du, ISRAEL SOTO, aka Izzy, aka EZ, and SUZANA VERA, as a result of their own conduct, and the conduct of other conspirators reasonably foreseeable to them, is at least 50 grams of methamphetamine (actual).

#### Count 3

On or about July 2, 2013, within the Southern District of California, defendant SUZANA VERA, did knowingly and intentionally import 50 grams and more, to wit: approximately 887.4 grams of methamphetamine (actual), a Schedule II Controlled Substance, into the United States from a place outside thereof; in violation of Title 21, United States Code, Sections 952 and 960.

#### Count 4

On or about October 4, 2013, within the Southern District of California, defendants DUNG VAN NGUYEN, aka Du, and THUY THU TU, did knowingly and intentionally possess, with intent to distribute, approximately 109.9 50 grams and more, to wit: of methamphetamine (actual), Schedule II Controlled Substance; a in violation of Title 21, United States Code, Section 841(a)(1), Title 18, United States Code, Section 2.

#### Count 5

On or about October 8, 2013, within the Southern District of California, defendant LOUIE JAMES ROBERTS, being a person who had previously been convicted in a court, that is, the Superior Court of

California, County of San Diego, of a crime punishable by imprisonment for a term exceeding one year, that is, on or about October 13, 2005, of First Degree Burglary in violation of California Penal Code, Section 459, did knowingly and unlawfully possess in and affecting commerce a firearm, that is, a Ruger .22 caliber handgun, serial number 16-78263; in violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).

#### FORFEITURE ALLEGATIONS

- 1. The allegations contained in Counts 1 through 5 are realleged and by their reference fully incorporated herein for the purpose of alleging forfeiture to the United States of America pursuant to the provisions of Title 18, United States Code, Section 924(d), and Title 28, United States Code, Section 2461(c).
- 2. Upon conviction of the offenses alleged in Counts 1 and 5 of this Indictment, defendant LOUIE JAMES ROBERTS, shall forfeit to the United States, pursuant to Title 18, United States Code, Section 924(d), and Title 28, United States Code, Section 2461(c), all firearms and ammunition involved in the commission of the offenses, including, but not limited to, a Ruger .22 caliber handgun, serial number 16-78263.
- All pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c).
- 3. The allegations contained in Counts 1 through 4 are realleged and by their reference fully incorporated herein for the purpose of alleging forfeiture to the United States of America pursuant to the provisions of Title 21, United States Code, Section 853.

As a result of the commission of the felony offense alleged in Counts 1 through 4 of this indictment, said violations being punishable by imprisonment for more than one year and pursuant to United States Code, Sections 853(a)(1) and 853(a)(2), Title 21, defendants DUNG VAN NGUYEN, aka Du, ISRAEL SOTO, aka Izzy, aka EZ, VEOVANH INSIXENGMAY, aka Baby, ERIC ALLAN GUFFIN, JAVIER CHAVEZ, aka White Boy, DIEN PHONG VO, LOUIE JAMES ROBERTS, THUYSENGNGUEN KOULAVONGSA, aka Nguen, and ERIN LINDSAY CONNELLY shall, upon conviction, forfeit to the United States any and all property constituting, or derived from, any proceeds that the defendants obtained, directly or indirectly, as the result of the offenses, and any and all property used or intended to be used in any manner or part to commit and to facilitate the commission of the violation alleged in Counts 1 through 4 of this indictment, including but not limited to:

- e. has been commingled with other property which cannot be subdivided without difficulty;
